ORDER OF BUSINESS

The Municipal Election Commission meeting of May 1, 2025, having been duly publicized, was called to order by Chairperson Ben Watson at 11:00 a.m. in the Council Conference Room on the third floor of the Municipal Center.

Per Section 30-4-80(e) notice of the meeting was posted on the outside doors of the Municipal Center, the main bulletin board of the Municipal Center located on the first floor, and the City of North Augusta website.

Present were Commissioners Alpha Dunbar, and Ben Watson. Also, in attendance was Jamie Paul, City Clerk, GIS Analyst Kevin Whaley, and City Attorney Kelly Zier.

ITEM 3: Administration of Oath of Canvassers

Clerk Paul administered the Oath of Canvassers to the Municipal Election Commission Members.

ITEM 4: Provisional Ballot Hearing, if necessary

Clerk Paul stated that both Aiken and Edgefield County Registration & Elections did not have any provisional ballots for the April 29, 2025 Municipal General and Special Election.

ITEM 5: Canvassing of Votes

MEC reviewed the unofficial numbers provided by Aiken County and Edgefield County. Clerk Paul explained that there were no failsafe ballots that were counted at Aiken and Edgefield County. She added that Aiken and Edgefield spreadsheets include the absentee and early vote totals. (**See Attachment #5**)

Clerk Paul reviewed with MEC the excel sheet that was done by GIS Analyst Whaley the night of the election with the MEC and that a review of the tape totals to the excel sheet the following day that was done

Clerk Paul and GIS Analyst Whaley that one write-in number was missed in Precinct North Augusta 29 and noted on the excel sheet. Clerk Paul explained that the reports provided by Aiken County Registration & Elections which include the early and absentee votes versus the tape totals that there was a minor discrepancy in the difference of totals ranging from 1 to 4 votes off. She stated that the difference of the vote totals does not impact the outcome of the candidate winners. She noted that Edgefield votes match the tape totals and the reports. She added that it is up to the MEC which numbers to certify for the record. (See Attachment #5a)

Discussion ensued relative to the tape totals and report totals.

MEC came to the consensus to use the Aiken County Registration and Elections reports for final vote numbers which include the early and absentee votes.

ITEM 6: Certification of the Official Results for the April 29, 2025 Municipal General Election

MEC discussed the official results and requested that the Clerk update the letter to the City's Mayor and Council to reflect the official results using the Aiken and Edgefield Registration and Elections report total sheets provided after the election.


Clerk Paul stated that she will update the letter with the combined vote totals for the MEC to sign and that she will provide a copy to Mayor Williams.
